MEET THE SPEAKERS



Luella Trickett

Executive Director, Medical Devices, Value and Access

Luella joined ABHI in 2019, with over 25 years' experience in the pharmaceutical and HealthTech industries. Her career has seen her hold numerous specialist manufacturing and commercial roles at Baxter Healthcare, with responsibility for a range of product portfolios across the HealthTech spectrum within the UK, Europe, Middle East and Africa.

In 2012, Luella was seconded to the Department of Health for nine months as the Industry Liaison for the NHS Procurement Review, a role which saw her engage with government and the wider Life Sciences sector to facilitate the sharing of ideas and best practice.

From 2015, Luella led Baxter Healthcare's Government Affairs and Public Policy agenda, where she was tasked with managing key policies impacting the HealthTech sector and the NHS - supporting change that enabled the adoption and spread of innovations that deliver whole-system value across healthcare settings.

Before joining ABHI, Luella Chaired the Association's Public Affairs Policy Group, and has been a Director of the Board at the British Specialist Nutrition Association.

A holder of a first-class honours Bachelor of Pharmacy degree, Luella and her husband have two daughters, and live in Berkshire.



Peter Ellingworth
Chief Executive, ABHI

Peter is Chief Executive of the Association of British HealthTech Industries (ABHI), the UK's leading HealthTech Trade Association, with 400 members operating across medical devices, diagnostics and digital health. Working at both national and regional levels with senior government and the NHS, ABHI is focused on ensuring that policies and practices support the growth of our members and industry, thus enabling access to effective and life-changing technologies for patients.

Peter represents the industry on several formal government bodies and committees. He is a member of the Secretary of State-led Life Sciences Council and served as the leading voice for the sector on the Advisory Group for the Innovation System Programme, overseen by Roland Sinker on behalf of NHS England. In 2025, he was appointed to the MHRA's National Commission on the Regulation of AI in Healthcare, where he sits on the Commission's Technology Working Group. He is also a member of the Board of the Office for Strategic Coordination of Health Research (OSCHR), where he is focused on building strong and productive links between the HealthTech industry and the wider science and research community. He previously served on the Board of the Accelerated Access Collaborative and was an advisor to the Department of Health and Social Care's MedTech Strategy Programme Board.

At a regional level, Peter has a long history of involvement, beginning with the inception of the Academic Health Science Networks and continuing through their evolution into Health Innovation Networks. He has held Board-level roles with Manchester and South London, and since 2018, he has served as a Board Director at Oxford & Thames Valley, where his leadership culminated in his appointment as Chair in 2024. Additionally, Peter leads ABHI's partnership agreement with the Shelford Group, a collaboration of ten major research and teaching hospitals in England, designed to strengthen NHS-industry relationships and accelerate research and innovation.

He is a Board Member of MedTech Europe and Chairs its UK Working Group, which focuses on developing support for the harmonisation of critical policy matters for our industry, such as regulation, sustainability, and data. He also leads ABHI's engagement with AdvaMed, through a joint memorandum of understanding, and the Global Medical Technology Alliance.

Peter has an extensive background in business with international companies in the UK and Europe and holds non-executive roles with early stage HealthTech companies. He is a committed champion for ABHI's important work on women's health.



Lord Ara Darzi
Paul Hamlyn Chair of Surgery, Imperial College

Professor Darzi holds the Paul Hamlyn chair of surgery at Imperial College, London, the Royal Marsden Hospital and the Institute of Cancer Research. He is director of the Institute of Global Health Innovation at Imperial College, London and an honorary consultant surgeon at Imperial College Hospital NHS Trust.

Research led by Professor Darzi is directed towards achieving best surgical practice through innovation in surgery and enhancing patient safety and the quality of healthcare. He has published over 950 peer-reviewed research papers to date. In recognition of his achievements Professor Darzi has been elected as an Honorary Fellow of the Royal Academy of Engineering, a Fellow of the Academy of Medical Sciences, a Fellow of the Royal Society and a foreign associate of the Institute of Medicine. He was knighted for his services in medicine and surgery in 2002. In 2007, he was introduced to the House of Lords as Professor the Lord Darzi of Denham and appointed Parliamentary Under-Secretary of State at the Department of Health.

Upon relinquishing this role in 2009, Professor Darzi sat as the United Kingdom's Global Ambassador for Health and Life Sciences until March 2013. During this appointment and beyond, Professor Darzi has developed his status as a leading voice in the field of global health policy and innovation and helps to guide the allotment of substantial research funding throughout the United Kingdom as a committee member for the Engineering and Physical Sciences Research Council (EPSRC) since 2013. In August 2015, Professor Darzi was appointed as non-executive director of NHS regulatory body, Monitor, which oversees the quality and performance management of healthcare services across England. Professor Darzi was appointed and remains a member of Her Majesty's Most Honourable Privy Council since June 2009.



Dr Zubir Ahmed MP
Parliamentary Under-Secretary of State for Health Innovation and Safety, Department of Health and Social Care

Dr Zubir Ahmed MP was appointed Parliamentary Under-Secretary of State at the Department of Health and Social Care on 6 September 2025. He was elected as the MP for Glasgow South West in July 2024.

Steve Bates OBE
Executive Chair, Office for Life Sciences

Steve Bates OBE is the Executive Chair of the Office for Life Sciences, leading efforts to strengthen the UK's position as a global life sciences powerhouse. From 2012 to 2025, he served as Chief Executive of the BioIndustry Association (BIA), where he played a pivotal role in championing the UK's biotechnology and life sciences ecosystem.

Steve has extensive experience spanning both industry and government. Before joining the BIA, he held senior leadership roles in biotech, including as Senior Director at Genzyme UK and Ireland. Earlier in his career, he served as Special Adviser to the Rt Hon John Reid MP during his time in Tony Blair's government.



Dr Sarah Byron
**Programme Director for Healthtech Strategy
and Development, NICE**

In this role, she works collaboratively with partners across the NHS and wider life science ecosystem to shape the HealthTech strategy at NICE and lead development projects that solve key challenges, both internally and externally. Most recently, Sarah led the development of the new Early Value Assessment approach for health technologies that address key NHS needs, helping to build the evidence base for widespread adoption through early deployment in the NHS.

Previously, Sarah was responsible for the NICE guidance programme evaluating the value of devices, diagnostics and digital technologies to improve patient access and care, and address NHS system challenges. Prior to NICE, she completed a PhD in Biochemistry and worked in the pharmaceutical industry.



Dr Niall Keenan
Consultant Cardiologist, West Hertfordshire Teaching Hospitals NHS Trust

Dr Keenan is a Consultant Cardiologist at West Herts Teaching Hospitals NHS Trust and an Honorary Clinical Senior Lecturer at Imperial College, London. He qualified from Oxford University in 2001 and then trained in cardiology in London. He carried out specialised training and research in cardiac MRI at the Royal Brompton Hospital, in cardiac CT at the London Chest Hospital, and in echocardiography at Hammersmith Hospital in London, and also at Hôpital Bichat-Claude-Bernard in Paris. He has also undertaken advanced heart failure training at Harefield Hospital.

At West Herts NHS Trust he is Divisional Director for Medicine. He was previously Clinical Director for Interventional Medicine and Associate Medical Director for Quality and Innovation. He is President-Elect of the British Society of CMR (BSCMR) and led a recent study of the state of CMR in the UK. Since 2020 he has been a member of the Scientific Documents (Guidelines) Committee of the European Association of Cardiovascular Imaging (EACVI). He has been Clinical Lead for the prize winning South and West Herts HCP Virtual Ward. He chairs the NHS England East of England Clinical Advisory Group for Virtual Wards, and sits on the NHS England National Steering Group for Virtual Wards.



Debra Padgett
Clinical Pathology Head of Service, Northumbria Healthcare NHS Foundation Trust NENC Pathology Network Operational Lead

Debra Padgett is the Clinical Pathology Head of Service at Northumbria Healthcare NHS Foundation Trust. She is also a Chartered Scientist and the NENC Pathology Network Operational Lead. With over 24 years of experience in clinical NHS laboratories, Ms. Padgett has been instrumental in leading transformational change programs that enhance service quality, workforce development and innovation in healthcare.

During her tenure as IBMS President (2022-2024) and over 12 years as an IBMS Council member, Debra has been a strong advocate for excellence in pathology services, ensuring that the profession remains at the forefront of national healthcare priorities. She has worked extensively with NHS England, the Royal College of Pathologists (RCPATH), and the Association for Clinical Biochemistry and Laboratory Medicine (ACB) on strategic initiatives, including the expansion of advanced practice roles, digital pathology adoption, and the implementation of national pathology transformation programs.

In her current roles, Debra provides leadership and operational oversight for pathology services across Northumbria and the wider North East and North Cumbria Integrated Care System (ICS). As Pathology Network Operational Lead for NENC, she has successfully transitioned the network from an emerging to a maturing status under the NHSE maturity matrix. She has also championed transformational change through digital pathology integration, streamlining workflows and improving diagnostic accuracy.

She serves as Lead Healthcare Scientist for Northumbria Healthcare NHS Foundation Trust, a committee member for the BSI ISO 15189 mirror committee, and a STEM ambassador. She has played a key role in national and international forums, leading discussions on pathology effectiveness, workforce strategy and healthcare resilience. She has chaired and contributed to high-profile events, including the APPHG House of Lords discussion on NHS recovery and the IBMS/ABHI roundtable on NICE guidance NG237.



Matthew Johnson
Director of Access & Innovation, Roche Diagnostics

With over 20 year's commercial experience, Matt has a proven track record of leadership, building high performing teams and fostering collaboration. He is passionate about strengthening partnerships to drive meaningful change and improve healthcare outcomes.

Matt began his career at Roche in 2002 as part of a graduate program and has since held multiple leadership positions across the UK and Ireland. In this role, Mr Lawson is the Government policy lead for Medical Technology with responsibility for the implementation of the Government's inaugural Medical Technology Strategy published February 2023. Key initiatives include the Design for Life programme, to promote circular economy; Value Based Procurement Methodology and associated MedTech Compass to support evidence based decision making and enable a Passporting System, to be adopted for MedTech procurement; NICE Multi-Tech Assessments of existing product categories; National Product Information Management System; National Outcomes and Registries Programme, National Equipment Tracking Information System, reform of the Part IX Drug Tariff which controls MedTech prescribed in the community. David is also SRO for the Innovative Devices Access Pathway bringing together MHRA, NICE, NHSE to provide enhanced support for novel technology that meets an unmet need, and member of the Independent Advisory Committee (IAC) for the newly launched NIHR HealthTech Research Centres (HRCs) Network. Prior to joining the Department, Mr Lawson was the Chief Procurement Officer at Guy's and St Thomas' NHS Foundation Trust – a position he held for 21 years – and is a double winner of the Supply Chain Excellence Award in 2008 and 2021.

Dr. Prabhu Arumugam is the Clinical Innovation Lead at Amazon Web Services (AWS), having joined AWS in July 2024. Before this role, he was Director of Clinical Data and Imaging at Genomics England, where he led work on integrating genomics with digital pathology and radiology imaging to advance cancer research and diagnostics.

Jacob Lant
Chief Executive, National Voices

He is a committed advocate for working with people accessing health and care services and the wider public to help improve the accessibility and quality of the care they receive. He loves to combine deep qualitative insights with quantitative data to challenge traditional thinking on how to tackle policy challenges. Prior to working for National Voices, Jacob spent almost 10 years helping to build the Healthwatch network. Chris Laing
CEO, UCL Partners

As Chief Executive Officer of UCLPartners, Chris leads our work as a health innovation partnership and provides executive oversight of the NHS Innovation Accelerator, working with its co-directors.

He joined UCLPartners in October 2021, initially as Director of our Health Innovation Network and National Director of the NHS Innovation Accelerator, before being appointed as UCLPartners Chief Executive Officer in February 2022.

Chris undertook specialist training in nephrology, critical care and internal medicine, and continues to practise as a consultant nephrologist at University College London and Royal Free Hospitals, where he is also Honorary Associate Professor of Nephrology at the UCL Centre for Nephrology.

He undertook research training in renal disease, genetics and physiology at UCL and INSERM Paris. He remained active in research through clinical trials, health services research and the use of artificial intelligence in predicting acute renal disease.

Previous leadership roles have included Training Director, Clinical Lead for Nephrology and Associate Medical Director of Royal Free London NHS Foundation Trust. He worked for four years as Divisional Director of Emergency Services in University College London Hospitals where he oversaw the acute care pathway, leading an extensive programme of transformation. In the latter role he also led the UCLH emergency care response during the COVID-19 pandemic. He founded and led London Acute Kidney Injury Network.

Chris has a strong interest in digital health, technology and data science and worked for five years as a senior clinical advisor to DeepMind and Google Health.



Ushma Baros

Ushma leads NHS Partnerships at Big Health. Big Health develops digital CBT programmes Daylight (for anxiety) and Sleepio (for insomnia). Daylight and Sleepio were two of the first four digital mental health tools commissioned by NHS England to support staff wellbeing during the pandemic and are available nationwide in Scotland. Before joining Big Health, Ushma worked at Kamet Ventures, a health tech venture building and investment fund and Deloitte, where she led NHS and health charity strategy projects. She was also a Governor at Central North West London NHSFT and volunteer at Crisis Text Line.

Matt has been in the healthcare sector since 2015 after a 15 year career working in private equity and banking.

Matt joined Kimal in 2015 to oversee two strategic projects for the business (its Cairo production facility and its new UK logistics hub). 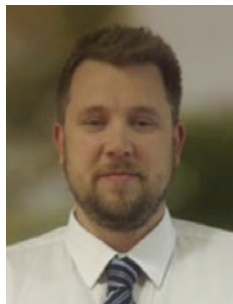
Prior to joining Kimal Matt worked for a range of investment companies with different portfolio focusses from UK real estate through to greenfield consumer goods factories in Ethiopia.
